**Data Process**

Among the Personal Information collected by this Application, either independently or through third parties, there are: Cookies and Users Data.

Personal Data may be freely provided by the data subject or, in the case of Users Data, collected automatically during the use of this Application.

Unless otherwise specified, all the Data required by this Application are mandatory. If the data subject refuses to communicate them, it may be impossible for this Application to provide the Service. In cases where this Application indicates some Data as optional, interested parties are free to refrain from communicating such Data, without this having any consequence on the availability of the Service or on its operation.

Any use of Cookies - or other tracking tools - by this Application or third-party service providers used by this Application, unless otherwise specified, has the purpose of providing the Service requested by the data subject, in addition to the additional purposes described in this document and in the Cookie Policy.

**Mode and place of processing of collected data**

**Method of treatment**

AGT SpA adopts the appropriate security measures to prevent unauthorized access, disclosure, modification or destruction of Personal Data.

Processing is carried out using IT and / or telematic tools, with organizational methods and with logic strictly related to the purposes indicated. In addition to AGT SpA, in some cases, other parties involved in the organization of this Application (administrative, commercial, marketing, legal, system administrators) or external subjects (as suppliers of third-party technical services, postal carriers) may have access to Data, hosting providers, IT companies, communication agencies) also appointed, if necessary, External Managers of the Treatment by AGT SpA. The updated list of Managers can always be requested at AGT SpA.

**Legal basis of the processing**

AGT SpA Personal Data concerning the data subject in case one of the following conditions exists:

- the processing is necessary for the execution of a contract with the data subject and / or the execution of pre-contractual measures;
- the processing is necessary to fulfill a legal obligation to which AGT SpA;



- the processing is necessary for the execution of a task carried out in the public interest or for the exercise of public authority to which AGT SpA
- processing is necessary for the pursuit of the legitimate interest of AGT SpA or third parties.

### **Place**

The Data are processed at the operational headquarters of AGT SpA and in any other place where the parties involved in the treatment are located. For further information, the data subject may contact AGT SpA

The Personal Data of the data subject may be transferred to a country other than that in which the data subject is located. To obtain further information on the place of processing, the data subject may refer to the section regarding the details on the processing of Personal Data.

You have the right to obtain information on the legal basis for the transfer of Data outside the European Union (Chapter V, Art 44 of the GDPR "Transfers of personal data to third countries or international organizations")

If one of the transfers described above takes place, the User may refer to the respective sections of this document or request information from AGT SpA contacting him at the extremes reported at the beginning.

### **Retention**

The Data are processed and stored for the time required by the purposes for which they were collected. Therefore:

- Personal Data collected for purposes related to the execution of a contract between AGT SpA and the data subject will be held until the execution of the contract is completed.
- Personal Data collected for purposes related to the legitimate interest of AGT SpA will be retained until this interest is met. The data subject can obtain further information on the legitimate interest pursued by AGT SpA When the treatment is based on the consent of the data subject, AGT SpA may retain Personal Data for a longer period until such consent is revoked.

Furthermore, AGT SpA you may be obliged to keep Personal Data for a longer period in compliance with a legal obligation or an order of an authority (for a maximum of 10 years).

At the end of the retention period the Personal Data will be deleted. Therefore, at the end of this term the right of access, cancellation, rectification and the right to data portability can no longer be exercised.

### **Data Process Purposes**

Personal Data are collected to provide the information requested through the site, therefore they will not be used for marketing or commercial purposes.

### **Data Subject rights**

The interested parties may exercise certain rights with reference to the Data processed by AGT SpA In particular, the data subject has the right to:

- withdraw consent at any time. The data subject can revoke the consent to the processing of their Personal Data previously expressed.



- oppose the processing of your data. You may object to the processing of your data when it occurs on a legal basis other than consent.
- access your data. You have the right to obtain information on Data processed by AGT SpA, on certain aspects of the processing and to receive a copy of the data processed.
- verify and request correction. The data subject can verify the correctness of his data and request the update or correction.
- obtain treatment limitation. When certain conditions are met, the data subject may request the limitation of the processing of their data. In this case, AGT SpA it will not process the Data for any other purpose other than its storage.
- obtain the cancellation or removal of their Personal Data. When certain conditions are met, the data subject may request the cancellation of their Data by AGT SpA
- receive your data or have it transferred to another holder. The data subject has the right to receive their data in a structured format, commonly used and readable by automatic device and, where technically feasible, to obtain the transfer without hindrance to another holder. This provision is applicable when the Data are processed with automated tools and the processing is based on the consent of the data subject, on a contract of which the data subject is a party or on contractual measures connected to it.
- propose a complaint. The data subject may lodge a complaint with the competent personal data protection authority or act in court.

### **Opposition**

Data subject has the right to object at any time, for reasons connected with his particular situation, to the processing of personal data concerning him, AGT SpA abstains from further processing personal data unless it demonstrates the existence of binding legitimate reasons for proceeding with processing which prevail over the interests, rights and freedoms of the data subject or for the establishment, exercise or defense of an right in court.

### **How to exercise rights**

To exercise the rights, data subject can send a request to the contact details of AGT SpA indicated in this document. Requests are filed for free and processed by Controller as soon as possible, in any case within a month.
